### Photo by Griffin Eckstein Workers quitting jobs at record rates

Since the pandemic, employees have been leaving jobs at record rates. For many, new management and working conditions play a role in why people are walking away. The number of job openings jumped to over 10 million in June, the highest on record. Many companies compete for workers by offering higher pay, bonuses, better benefits, and more accommodating schedules.

The number of Americans leaving their job hit historic highs in 2019 before the pandemic, but quits have been over 3.6 million for each of the last three months. According to Jennifer Liu, "The latest jobs report says 8.7 million Americans are looking for work, meaning there are currently more than 1 million more job openings than people who can fill them. But unemployment numbers don't capture the millions of people who are misclassified, experienced a pay cut or drop-in hours, or had to stop looking for work altogether." After being asked why he left his job, Dylan Cornwell says, "I left almost entirely because of new policies that were introduced... When I started there was absolutely no regulation and it was all very relaxed but about two weeks ago the whole job changed... and I needed to leave. We also had another employee leave because of this and another two putting in their notice."

Workers are making decisions to leave based on how their employers were treating them and if they could get higher pay and better working conditions somewhere else. 4 million people quit their jobs in April alone, and studies show that workers in the labor market are coming out with higher wages. The average wage growth across the country has increased 1.5% in June, and 5.8% for job switchers, stated by Jennifer Liu. Dylan Cornwell states his opinion on minimum wage and says, "I think minimum wage should absolutely increase to make life more liveable." Continued on next page

Cornwell says "An increase in the minimum wage wouldn't only help teenagers buy a new car or clothes, but can help unskilled workers who can't afford a higher education... actually live life... Our federal minimum wage hasn't changed in over a decade and the

## Youth Substance Abuse

Research by the National Institute on Drug Abuse suggests that in 2019, 35 percent of teens in the US admitted that they had tried a form of illicit drugs.

Studies conducted by the National Center for Drug Abuse Statistics show that 8.33 percent of 12 to 17 have teens used uncontrolled substances in the past month. Drugs are not only becoming addictive and hurting these kids, but they are killing them. In 2017 alone, 18.2 percent of 8th graders said they had tried a drug or other substance, and there were 5,455 deaths caused by overdose in young teens. Leo, a former Narcotics Agent, says, "It's like a glue trap, they get into it easily, but once they are in it, they are stuck". Once the child starts getting addicted, the only way out is to seek help, but many will not because they feel they may get in trouble or they may not want to stop at all.

In 2020, 21.3 percent of kids said they had tried some form of narcotic. Ms. Vaughn, a homicide detective, says "Personally, I have seen a saddening trend in cost of living was much lower in 2009 than 2021... Increasing it would help workers be able to afford housing and bills without working multiple jobs." Job-switchers are joining employees with at least 500 workers who are making higher gains.

## Supreme Court rules to allow Texas abortion restrictions

The United States Supreme Court ruled 5-4 not to stop a Texas law banning abortions after 6 weeks from going into effect. The law, which, according to Justices Roberts, Kagan, Sotomayor, and Breyer in their dissenting opinions, violates the Supreme Court's ruling in Roe v. Wade, is now one of the nation's strictest since going into effect on September 1st.

The Court ruled in Roe v. Wade to ensure the right to legal abortions to people in all 50 US states in 1973, and has since prevented states from instituting laws violating reproductive rights. At that time, the court argued that the right to receive an abortion was a private choice, and thus protected from government restriction. In this recent decision, the court rejected an application for injunction from Whole Women's Health, a Texas-based healthcare provider, allowing Texas's ban on abortion after 6 weeks to stand. While the majority Justices did not issue a signed opinion, dissenting Justice Sotomayor said in her opinion, that "the Act is clearly unconstitutional under existing precedents."

The future of abortion rights remain undecided, with the ruling stating that the court "do[es] not purport to resolve any jurisdictional or substantive claim in the applicants' lawsuit." In other words, while the Court allowed the law to stand on procedural grounds, they have yet to make a ruling on its constitutionality, arguing only that they cannot stop it from going into effect.

The bill could restrict reproductive rights from as many as 85% of Texas patients, according to Sotomayor, and may inspire other states to pass legislation that challenges the precedent of Roe v. Wade.

"**Any person ... may bring a civil action** against any person who performs or induces an abortion ... [or] knowingly ... aids or abets the performance or inducement of an abortion, including paying for or reimbursing the costs of an abortion" - Texas Senate Bill 8

## Vaccine Boosters: What do we know so far?

In the past months, a third dose of the COVID-19 vaccine has been highly discussed; however, a large number of people may not be entirely informed on what that means.

The technical definition of a booster shot is an additional vaccine dose that is periodically needed in order to do its job and 'boost' the immune system.

The CDC says, "An additional dose may prevent serious and possibly life-threatening COVID-19 in people who may not have responded to their initial vaccine series." The word "may" advises all audiences to take this statement with a grain of salt. It is expected to help, although the results are not definitive. According to Pfizer, out of those who were a part of the first phase clinical trial, the "third dose elicited significantly higher neutralizing antibodies against the initial SARS-CoV-2 virus".

For now, federal health officials are monitoring the side effects as well as the potential risks and benefits of the booster shot. The benefits seem to be outweighing the potential risks. The side effects are very similar to that of the previous two vaccine shots. Some of the side effects that are being watched range from fatigue and pain at the injection site, to myocarditis and heart-swelling. However, the more severe side effects have shown up in a very small number of people.

COVID-19 booster shots are expected to be released beginning the week of September 20th and offered to individuals who received their second vaccine dose at least 8 months prior.

## Historic Arizona wildfire season devastates flora, fauna

Arizona's dry and sweltering environment is a perfect formula for wildfires, and this season was no exception. With over 1100 wildfires that have ravaged 550,000 acres of land, this season has been exceptionally damaging to plants, animals, and humans alike.

Fueled by drought, high temperatures, human carelessness, and lightning scorching the earth, an overabundance of fires has sprung up all across Arizona. While the heavy rains have been beneficial to halting the spread, it is far too little too late. Over 30 wildfires are actively burning in Arizona from the time this was written. "The 2021 fire season is already shaping up to be a big one, at more than 177,016 acres burned so far," said Garrett Archer of ABC-15 news on June 10, 2021. This figure is already greater than six of the last 20 years of wildfires, with a top 10 fire having started this season as well. The Telegraph fire, near Superior, claimed over 180,000 acres and required over one thousand firefighting personnel to combat the sixth most destructive wildfire in Arizona history. Marvin Percha, an meteorologist, told Arizona AZCentral.com, "Fire danger levels are definitely above normal. Right now, most of the state of Arizona is in extreme to exceptional drought". Once this perfect storm of factors is set up, it does not take much instigation to cause all of the dry grasses and forests to catch alight.

As of now, all major wildfires over 50,000 acres have been 100% contained, but multiple small blazes pop up at a nearly constant rate around Arizona. Throughout the 2021 wildfire season there have been two fatalities, both caused by an aircraft accident while battling the Cedar Basin fire near Wikieup. The plane crash left no survivors, killing retired fire chief Jeff Piechura and pilot Matt Miller.

Year after year, Arizona reaches new highs in terms of temperature, and these fires and the incidents correlated with them will only pick up in frequency. The fires occurring over the last five years have been gaining in the level of destruction, with 2020 seeing 978,000 acres burned to the ground. Although the land claimed so far in 2021 is considerably less than last year, it has had a devastating impact on the wildlife in the area, with reports saying that it could take close to 80 years for the forests to fully recover from the ordeal. There is no way to completely remove wildfires from the equation, but all Arizonans should take increased precautions and remain alert in the likely event of this natural disaster striking near you.

Some steps that can be taken to make the transition easier are:



### 4. Study With Classmates


Having other people around while studying can be very helpful and benefit multiple people with the subject.

People like murder. Generally, people dislike committing murder and being murdered—but we have a morbid desire to hear about it. True crime as a genre has grown exponentially in the past few years. An article from The Everyday states that there are now over 2800 true crime podcasts to choose from. A new docu-series or investigation will incite a buzz that spreads around campus in a matter of days. So, of course, we're buying into the overdone drama of true crime. Welcome to True Crime Chandler. Our first story is Katherine Knight, Australia's Hannibal.

October 24, 1955. Katherine Knight is born as the youngest twin to Barbara Roughan and Ken Knight. Kathrine Knight had a terrible childhood. Her father was an alcoholic who used intimidation and violence to rape his wife, who would then share intimate details of her sex life with her children. Knight also claims she was frequently sexually assaulted by several members of her family. In her high school years, Knight was remembered by her classmates as a bully who assaulted at least one boy at school with a weapon. She left school at 15 and proceeded to work at an abattoir twelve months later -otherwise known as a slaughterhouse.

Knight claimed this was her dream job. She hung her first set of butchers knives over her bed wherever she lived, so 'they would always be handy if I needed them'.

Knight had several failed relationships/marriages, children, and instances of assault. She strangled her first husband on their honeymoon, stole an ax and threatened to kill people after placing her two-month-old child on a railway line, and slashed a woman's face with one of her knives and demanded she drive Knight to see her ex-husband. She was never convicted on any charges.

Knight's last relationship was with a man named John Price. In early 2000, a series of assaults resulted in Knight stabbing Price and him subsequently placing a restraining order against her for him and his children. On the same afternoon he placed the order, he told his coworkers that if he did not show up for work the next day, it was because Knight had murdered him.

Price arrived home that night to find Knight waiting for him. Price's children had been sent over to a friend's house. Earlier that day, Knight had videotaped her own children making comments, which has since been interpreted as a crude will.

At 6 a.m. the next day, a neighbor became concerned after seeing Price's car still in the driveway. An employee from Price's work was also called to investigate. They called the police after finding blood on the front door. Police arrived at 8 a.m., broke down the front door, and walked into Price's bedroom. The officer was supposedly hit face first with a bloodied towel hung over the door. Price's body was arranged with one arm over a large soda bottle with the legs crossed, a position that claimed to show Knight's contempt for Price. He was decapitated and several parts of his body were also removed. An autopsy revealed he had been stabbed at least 37 times.

Upon closer inspection, it was not a towel hung over the door. It was a large piece of Price's skin. In the kitchen, two plates of stew were found plated with assorted vegetables and the cards with the names of Price's children beside them.

Price's head was staring up from the still-warm pot of stew.

Knight was sentenced to life imprisonment without parole, becoming the first Australian woman to ever receive the sentence. She originally pled non-guilty, but then changed her plea to guilty with no reason publicly given. Many psychiatrists considered Knight sane, though her legal team used psychiatric evidence that she experienced amnesia and dissociation at the time of the murder to argue an insanity plea. Two psychiatrists concluded that Knight suffered from a borderline personality disorder.

The culprit is clear, yet this still feels like a cold case. No reason for the murder was ever found by officials or offered by Knight -- by all means, it could have simply been a passion killing. As gruesome and extreme as it was, one can't help but wonder: what drives a person to commit such a crime?

What drives us to learn about it?



## The Tangible Impacts of Climate Change

When Hurricane Harvey destroyed my grandma's house in Texas, I became much more aware of the dangers of climate change and the dangers of ignoring it.

Our climate is changing as a result of the atmosphere being thickened by industrial emissions of carbon dioxide, methane, and nitrous oxide. These molecules prevent the sun's heat from escaping the atmosphere when it is reflected off the earth's surface, thereby trapping the heat like a coat, which has caused irreversible global warming and heat extreme waves. This is also increasing the temperature of trade winds and ocean waters which causes more

severe hurricanes. Higher air temperatures also retain more water in the atmosphere, which is causing droughts. In turn, these droughts make wildfires more severe because more plant material is dry enough to ignite.

My aunt sent us a video of a California wildfire in her suburban Anaheim neighborhood, which was horrifying and heartbreaking to watch. The once lush green rolling hills were unrecognizable and resembled the aftermath of a volcanic eruption.

The California wildfires, Louisiana hurricanes, extreme blizzards, the throat-burning New Delhi smog, the Arizona drought are happening now, taking lives now, and can no longer be ignored.

Yes, Global Warming is also separating polar vortexes of cold air at the poles and moving them farther south, which is causing extreme low temperatures in the Northeast U.S. This is why it is incorrect to assume that pollution isn't changing the climate just because a city has cold temps.

With hurricanes, a rise in temperatures has caused a rise in sea level from polar ice caps melting, and a rise in temperatures above the ocean increases the amount of water vapor pulled into storms, which has caused the devastation of hurricane Ida in Louisiana which moved across land to New York and New Jersey and caused deaths from flooding there as well.

Solar power, water usage, and waste reduction are our club's focus. We will be continuing these projects as well as spreading awareness about sustainable practices individuals can make. In terms of a call to action for readers, 'Over two-thirds of Americans believe the government is doing too little to reduce effects of climate change' (Pew Research Center).

Firstly, call your representatives to voice your concern. Just 100 companies are responsible for 71% of global emissions, so these polluters, rather than individuals, should be the focus of regulations. Sign petitions and donate to funds to help people affected by the climate crisis whether in Flint, Michigan or Lagos, Nigeria.

In your day-to-day life, be mindful of your purchasing. If a clothing item is cheaply made and will go out of style in a few years, consider saving your money. Dyeing and bleaching processes release toxins into the air that instantly harm the lungs of factory workers and harm worldwide air quality.

Many clothing materials require crude oil to be extracted from the ground and are woven with plastic, which does not biodegrade (break down into reusable materials in the ground), making it a perpetual polluter. Many clothing and plastic items also have to be shipped overseas from China, which uses a lot of energy.

Eating less meat also helps reduce your carbon footprint, because beef requires much more water and energy to produce than similar foods, and cows release methane, which traps heat in the atmosphere.

The most important advice I could give is this: do not lose hope.

## **America Needs A New Labor Rights Movement**

With the impacts the pandemic has had on many US workers, combined with the possible passage of the PRO Act, Americans have a rare opportunity for a period of renewed labor rights.

The pandemic, though initially leaving many unemployed, has led to more workers questioning their true worth to their employers. As the economy restarted, businesses struggled to fill vacancies, with many workers demanding higher wages, more workplace protections, and better conditions. Chandler senior Lily Taylor says, "people have started to open up the discussion of being overworked ... and started to understand that if you overwork your workers then nobody is going to want to work for you."

Many workers in the US feel empowered to ask for increased benefits. but an even greater opportunity for progress in labor rights comes from a piece of legislation currently working through Congress. The PRO Act, or Protecting the Right to Organize Act, passed the House of Representatives earlier this year, and broadens the rights of unions and employees to organize, and restricts corporate anti-union actions.

According to the AFL-CIO, the largest federation of labor organizations in the US, the PRO Act would "[restore] the right of workers to freely and fairly form a union and bargain together for changes in the workplace." In addition to union support, a bipartisan majority of the American public supports the PRO Act. A Vox and Data for Progress poll conducted earlier in the summer of 2021 found that "40 percent of Republicans support the PRO Act, along with 74 percent of Democrats and 58 percent of independents. Overall, the poll found the bill has the support of 59 percent of likely voters."

The bill now heads to the U.S. Senate, where a vote has yet to be the current scheduled. Under chamber rules, the bill would require 60 votes, likely all 50 Democratic senators joining at least 10 Republican ones, to overcome the filibuster. Though it faces a difficult path, PRO the Act is а once-in-a-generation opportunity to secure workers a better future. Adults and teen workers alike stand to regain their ability to organize and demand better conditions, better pay, fair treatment from their and employers.

Without a mandatory dress-out for P.E., students would likely go to the gym wearing everyday clothes that may not be suitable for the exercises they do in class. However, several students agree that there are some issues regarding the P.E dress-out requirements at Chandler High.

Anyone who has or is currently taking a physical education course at CHS is likely aware of the requirements: a CHS P.E. shirt, basic athletic pants and or shorts in CHS colors, and athletic shoes. P.E. teachers recommend that students have at least two shirts, two pairs of pants and or shorts, and one pair of athletic shoes.

Generic athletic bottoms and shoes are easy to obtain. Various retail stores sell athletic bottoms and shoes for relatively low prices. However, getting the CHS P.E. shirt can be a struggle. The shirt is exclusively available at the campus Bookstore for \$7.50. While students have a week to obtain the shirt, this can still be an issue. The shirt is less easily accessible for families struggling with finances, especially since the recent pandemic. Some students are also unable to buy the shirts for other reasons. Samantha Bourland, a strong supporter of the use of dress-out, even agrees in saying, "I think that we should not have to wear specific shirts. We should be able to wear tank tops or other clothes that we feel comfortable wearing."

Another issue with the dress-out requirements is its conflict with cultural clothing, most notably for Muslim students. Islam has a code of modesty, with both boys and girls typically wearing clothes that cover a large portions of skin. To comply with both the dress-out requirements and their culture, many Muslim students layer on additional clothing, or walk around in the heat while their friends are swimming on block days.

Chandler High's P.E dress-out requirements need some tweaks. When surveyed, one Chandler student suggests, "They should allow spaghetti straps, allow breathable clothing such as workout clothing, even permit wearing sports bras with no shirt."

## **Athletes Shape Mental Health Conversation**

The 2021 Olympics in Tokyo have started a global conversation surrounding athletes and mental health. Simone Biles, the 24-year-old gymnast who recently announced her withdrawal during the Olympics from several events, caused many different opinions to arise. One of the most important conversations brought up was the pressure that many athletes face while practicing and competing in their sports. Often these athletes face immense amounts of criticism and hear countless others' opinions. However, it's not always the fault of the general public. This stems back to even high school sports, where athletes have little time for anything besides their sports and struggle to stay afloat in school.

When taking a closer look at some athletes from the surrounding areas, the pressure against their mental health was even clearer than before. In a recent poll of 191 students, 86% reported that they feel that the intensity of their sports was enough to negatively affect their mental health. Marco Palafox, a junior who participates in wrestling, football, and track, recently gave his opinions on high school athletics. He admitted that football overall put the most stress on him, especially after suffering a serious injury. At the end of his sophomore year, he tore his ACL, undergoing a 7-month process of recovery. During his recovery, he said that he "skyrocketed down because I felt like an outlier and helpless." These sports had such a large part in Palafox's life that he felt like an athlete first and foremost, and wasn't even able to focus on himself during one of the most difficult injuries he could have. Another student, Ryan Liu, had a similar opinion. When

asked how Sanda—a full-contact combat sport—affected him, he admitted that he did quit his sport at one point "not because I got hurt but [because] I hurt other people". These experiences don't only affect the person themselves, but they can also affect everyone around them. He talked about feeling regret about how his fighting affected others. Liu explained, "I accidentally hurt other people too much while defending myself." This perspective showed the risks that can come with different sports, especially ones of high intensity. These accounts make what was already somewhat known very clear. Athletics are extreme stressors that affect anyone from a high school football player to an Olympic gold medalist.

With the correlation between Simone Biles' leave and high school athletes' mental health, it is clear to say there is an underlying issue. However, there is no definite answer to what the critical factors may be: over-working, lack of social contact, major injury, etc. It really is something to take into consideration while joining a sport. However, Biles is back in the 2020 Olympics, Palafox is healed, and Liu is back in Sanda. There is still something to look forward to: passion, happiness, or the whole world rooting for you.


