On May 17, 2022, the Arizona state legislators passed house Bill 2453 making requiring a face mask prohibited and was signed by Governor Ducey on May 20, 2022.</p> <p>NO</p>	<p>Face coverings will be optional for the 2022-23 school year and school sites will maintain a heightened awareness of student and staff behavior regarding mask bullying. Although mask wearing is optional, all students and staff are encouraged to use face coverings to help prevent the spread at school.</p>
Modifying facilities to allow for physical distancing (e.g., use of cohorts/podding)	<p>CUSD COVID mitigation plan was shared with the governing board</p> <p>NO</p>	<p>Currently, CUSD will continue to evaluate the need to observe physical distancing throughout the school year. CUSD will increase focus on student cleanliness and hygiene as distancing continues to be difficult.</p>
Handwashing and respiratory etiquette	<p>CUSD COVID mitigation plan was shared with the governing board</p> <p>NO</p>	<p>CUSD continues to focus on hand hygiene with sanitization stations placed around the school. Daily, students and staff are encouraged to wash their hands often with soap and water for at least 20 seconds, especially after having been in a public place or after blowing their nose, coughing, or sneezing.</p> <p>Always cover mouth and nose with a tissue when coughing/sneezing or use the inside of the elbow when a cloth face covering is not available.</p> <p>Students and staff must throw used tissues in the trash and utilize facility sinks for soap and water to ensure cleanliness.</p>

In addition to in-person instruction, all students in grades 1-12 will have the opportunity to enroll in Chandler Online Academy, which is the approved online provider for Chandler Schools. CUSD has implemented multiple options to ensure students are able to participate in quality learning experiences regardless of the delivery model.

Academic Needs	<p>Students' academic needs will be met through the implementation of teaching the curriculum using adopted resources in Tier I instruction. Utilizing our Multi-tiered System of Supports, differentiation within the classroom will be implemented to intervene when skill sets are identified as a need for intervention for our students to assist in the learning recovery process. <p>Social, Emotional and Mental Health Needs</p>	<p>Students receive prevention and intervention lessons in all grades from social emotional cognitive learning adopted curriculum. All tiered mental health deliverable pieces are from evidence-based curriculum. Targeted interventions are based on needs of students and are provided in a small support group model as well as individually. Crisis level intervention is available for students with an emphasis to support family structure which includes referrals and resources to community partners.</p> <p>Mental health forums: CUSD is currently working with the City of Chandler and other community organizations to offer community forums in the areas of mental and behavioral health. The tentative start date is September of 2022. These forums may include the following, National Expert presentations, panel discussions, and roundtables to gather feedback.</p> <p>CUSD will also release an RFP to determine the available resources to assist in addressing mental and behavioral health needs of our students. This is scheduled to be released during the 1st semester of the 2022-2023 school year.</p>
<p>Other Needs (which may include student health and food services)</p>	<p>CUSD will continue to follow recommendations and infection prevention protocols from public health partners in the school health office.</p> <p>The health office staff will continue to educate and exclude students based on public health exclusion guidelines. All individuals entering any building on district property will be required to self-monitor for symptoms. Anyone with COVID-19 like symptoms should not report to school/work.</p>
<p>Staff Needs:</p>	
<p>Social, Emotional and Mental Health Needs</p>	<p>Staff receives ongoing education and training on secondary trauma effects, burnout and healthy coping skills via a variety of mediums. These deliverables include: the mental health staff, human resources, community partners and opportunities through professional development with a focus on wellness. Additional supports are available through employee assistance programs. A strong focus is placed on physical and mental health and work life balance education.</p>

CUSD will continue this process to ensure a safe learning environment for students, teachers and staff.</p> <p>On May 3, 2022, CUSD administration shared the district 2021-2022 plan with all CUSD site COVID committee employees' groups to gather feedback on possible changes for the 2022-2023 school year.</p> <p>Upon review of feedback from the employee groups, this information was utilized to update the 2022-2023 Safe return to In-Person plan which was set to electronically to all CUSD families on May 27, 2022, to ensure all families were informed of the district's mitigation plan. Feedback received from parents, teachers and staff members will be reviewed throughout the year to determine any additional updates moving forward.</p> <p>All feedback gathered from the community, teachers and staff was reviewed and considered prior to the creation of the final plan.</p>
