### Quick Guide for Parents Extracurricular Activity Fees & Tax Credit Contributions

To go to the Infinite Campus Parent Portal, click here:

This year ALL extracurricular activity fees paid will be considered a tax credit contribution that you will be able to utilize on your taxes. The Arizona State tax credit, allows an Arizona taxpayer to contribute \$200 per Arizona state individual tax return or \$400 per joint tax return if the taxpayer contributes to extracurricular activities or character education programs in a public school.

#### Making a Payment on Infinite Campus

## Q&A

1. **I don't currently have a user ID for Infinite Campus, how do I register for one?**  
To create your CUSD Infinite Campus Parent Portal Account please visit the following link:

2. **Can I pay my child's fees from my mobile device or tablet?**  
Yes, however, you will need to use your phone or tablet's web browser to access Infinite Campus to make a fee payment or donation. The Infinite Campus app does not yet have the functionality for fee payments.
3. **Why is there a \$2 transaction fee?**  
The \$2 transaction fee is a convenience fee for using Infinite Campus to make payments from your home, work or mobile device with the use of a credit, debit card or e-check. The fee is assessed per transaction not per extracurricular activity fee as long as you signed into the Parent Portal.
4. **Can I still make cash, check or money order payments at the school?**  
We encourage parents to utilize the Infinite Campus online payment system but cash, check and money orders will still be accepted. You will need to complete an Extracurricular Activity Fee/Tax Credit Contribution Form if you are paying by cash, check or money order and submit to your child's school with payment.
5. **How do I make an additional tax credit contribution on top of my child's extracurricular activity fees?**  
To make an additional tax credit contribution you may select an optional fee for any grade level from the drop down menu in the Payment section of Infinite Campus. The amount defaults to \$200 but can be adjusted to any amount with a minimum of \$5. See image 2 above. Please pay any assigned fees prior to making an optional donation.
6. **Can other family members or friends pay for my student's fees on Infinite Campus?**  
Since Infinite Campus is linked to student information only primary guardians will be able to access Infinite Campus, however, all other individuals will be able to make tax credit contributions via [www.chandlerdonations.org](http://www.chandlerdonations.org).
7. **Can I print my tax credit receipt from Infinite Campus?**  
Your official receipt for tax purposes will be mailed to you by the District Office within 2 weeks of your contribution. At any time you can print your payment history from the Infinite Campus website by selecting the following links Family > Payments > View Your Online Payment History. To generate a printable version, select the "Download PDF for Printing" button.
8. **Do I have to claim the Arizona State tax credit?**  
It is completely up to you whether or not you choose to claim the Arizona State tax credit on your taxes.
