

Dear Parents,

In compliance with the Governor's Executive Order 2020-51 and in effort to provide support for students who need it, our campus will be open, starting August 17<sup>th</sup>, Monday-Friday, during the following times for access to technology and learning. Please note that Carlson has limited capacity due to the presence of the Kids Express child care program using our facility. Currently we can only enroll 16 students per session per day and still be in compliance with safety standards. The following times will be offered on a first come first serve basis. Registration can be found using the enclosed Sign Up Genius Link below.

**Session 1:** 8:00am-11:00am  
**Session 2:** 12:00pm-3:00pm

Please read the following guidelines about this program being offered.

- Supervision and learning support will be provided for registered students only (Kindergarten-Sixth Grade).
- The campus will have the computer lab available for registered students to be supervised as they complete online classwork.
- Students may have access to a district device based on availability but are encouraged to bring their personal device or CUSD issued device as well as headphones and power cord.
- Parents are required to transport students to and from the campus. There will be NO district transportation provided.
- With limited space and staff available, and in alignment with our health mitigation strategies, we highly recommend that students only remain on campus for the amount of time necessary to complete their online classwork as there are no activities provided outside of supervised online classwork.
- Should a student be registered on campus for both sessions (full day) it is expected that he/she bring material such as books, art supplies, and/or individual games which may assist in giving them an activity to complete after coursework is finished.
- Students registered for both sessions (full day) must bring their lunch to be eaten at the designated break time. Please see the CUSD website at <https://www.cusd80.com/CurbsideMeals> for curbside meal distribution for families.
- There will be no recess, specials, or direct instruction. All instruction is provided via our online/virtual platform.
- Lunch will not be provided. Your child must bring their lunch should they be signed up for concurrent sessions.
- Facial coverings will be required for all students who participate and will be worn when appropriate physical distancing cannot be maintained.
- **COA Students Only:** Please visit your child's homeschool webpage where the weekly sign-up link is made available.
  - ALL Students who participate in on-site learning MUST bring their **Parent Acknowledgement Form** when they first arrive to participate. This form is only required once during the child's participation and can be accessed by clicking
