Course Description and Objectives

This is an advanced elective course that focuses on plant sciences specifically within plant production. All students will be required to have a Supervised Agricultural Experience (SAE) and participate in the FFA where you will receive premier leadership and skills for career success. A primary focus within this course is to prepare students for the Technical Skills Assessment that students will take once they have completed the AgriScience Program sequence. For students to meet the guidelines set by the state and advance towards becoming competitors of the agriscience program, the plant science course is designed as a fast-paced course that builds student knowledge of the Plant Science Industry.

This course, when paired with Agriscience II, can be taken for a laboratory science credit.

Grading

This course consists of three components: Agriculture Instruction/Curriculum, Supervised Agriculture Experience, and the FFA.

- <u>Agriculture Instruction/Curriculum</u>: Grades are not given, they are earned. Grades will be determined by the degree to which objectives are met, success is achieved, timeliness, neatness, and original work. As this is an advanced class, students are expected to keep up with the pace of the coursework. If you are struggling with the class, I am available for extra assistance during conferences and after school.
- 2. <u>Supervised Agriculture Experience (SAE) Project</u>: Students will be expected to design a SAE plan in the 1st quarter and implement it by the 2nd quarter. Students will keep an electronic record of this project and are expected to take photos of their project throughout the school year. It will be the responsibility of the student to keep accurate records throughout the school year and submit these records on time to the instructor.
- 3. FFA Leadership Grade: A major aspect to this course is the development of leadership skills, speaking abilities, teamwork and other various skills that will play a major role in every individual's career choice. Students are required to participate in the local FFA activities and have the opportunity to participate in the district, state and national FFA activities. This will count towards 20% of each semester's grade. Please refer to the attached sheet for dates of the required events.

Conference Period and Tutoring Policy

Missed labs must be made up after school within one week. If you do not understand the assignment please ask, I am here to help you. Class time will not be used to explain missed work.
