Tax Credit

- Principal Cole presented Tax Credit policies and procedures and provided a financial report detailing the
 actual general tax credit expenditures for July 1, 2020-June 30, 2021. The Site Council members approved
 the expenditures.
- Principal Cole presented Tax Credit policies and procedures and gave an overview of the areas upon which
 Sanborn Elementary has been or will be spending 2021-2022 Tax Credit monies, including: grade level field
 trips; transportation for field trips; Student Activity clubs (Drama, Running, Chorus, Tutoring, etc.); CoCurricular areas including band, orchestra and choir; Character Education, Art Masterpiece, and Spelling Bee
 Programs; student health care supplies; playground equipment; shade structures; furniture/equipment; and
 fees for extracurricular activities or programs for which payment would represent an economic hardship for
 a student. Site Council agreed that the above-mentioned items were appropriate for the spending of general
 tax credit monies, retroactive to July 1, 2021.

Schoolwide Title I Status Granted

- Sanborn is now schoolwide Title I which means we can now use Title funding towards materials for any students grades K-6. When we were "Targeted" title (the past two years) we were somewhat restricted on how the funds were to be used.
- It is possible our Title I funds will be increased in 22/23 which might enable to use bring on a Math Specialist, while still keeping our Reading Specialist Renee.
