#### Biden Lifts Transgender Military Ban

On January 25th, 2021, President Joe Biden signed an official executive order lifting the Pentagon's ban on transgender people joining the U.S military.

The ban was put in place by the Trump administration back in 2017. When the ban was first being devised, Trump tweeted "Our military must be focused on decisive and overwhelming ... victory and cannot be burdened with the tremendous medical costs and disruption that transgender in the military would entail." Before Trump's presidency, former President Barack Obama not only allowed transgender personnel into the U.S military, but he also allowed them to receive transition

when speaking to reporters, President Biden said, "What I'm doing is enabling all qualified Americans to serve their country in uniform, and essentially restoring the situation as it existed before, with transgender personnel, if qualified in every other way, can serve their government in the United States military."

According to ABC News, "It is unclear how many transgender people serve in the military, though some advocacy groups have said it could be high as as 15,000 individuals." And to this, Marine Corps Capt. Emma Shinn says, "I am elated that the approximately 15,000 transgender service members proudly serving across the globe can rest easier knowing that their service

to our nation is seen, valued and that they can continue to serve as their authentic selves."

Also in support of President Biden's decision to lift the ban is new Defense Secretary Lloyd Austin. He said in a statement, "I fully support the President's direction that all transgender individuals who wish to serve in the United States military and can meet the appropriate standards shall be able to do so openly and free from discrimination."

He also mentioned that he believes it is not only the right thing to do but the smart thing to do. President Joe Biden plans to allow transgender Americans who are qualified to serve in the U.S military as of 2021.

## **Canada Detaining Canadian Citizens**

Canada's new travel restrictions went into effect on February 7th. Canadian citizens traveling back into Canada must have a negative COVID-19 test and must quarantine for 14 days upon arrival. Travelers must submit a 14 day plan for self-quarantine to the government. If not approved, they must spend their quarantine in a government facility. Approval of the quarantine plans has no parameters and is under the discretion of a government official. To leave the country, travelers must pay over \$2000 to stay in a government mandated hotel while waiting for a COVID-19 test. There have been reports of several Canadians being forced into government hotels for quarantine regardless of their COVID-19 tests or previous quarantine plans.

According to the Toronto Sun. Steve Duesing was detained in a hotel room in the Radisson hotel after landing at Pearson airport on January 31st. He entered the country with a

negative test that accepted and was told quarantine in the hotel while waiting for another test. Duesing was told the test would take 48 hours for results, but after that time had passed he received no information. Duesing released photos of the room, where a guard was stationed to ensure he did not leave. He also released photos of the food; a ham sandwich one day and a bagel and apple the next. According to Duesing, he received only four water bottles a day. The JCCF, a Canadian legal organization, says the Canadian government faces a lawsuit for unlawful confinement, arrest without charge, and refusal inform family of the to whereabouts of these Canadian citizens. This news comes after several Canadian officials admitted to breaking COVID-19 travel laws to go on family trips out of the country, including eight officials in Alberta alone where COVID-19 numbers are the highest.



In 2019, the FBI reported that there was a 14% increase in hate crime from 2018. However, the ADL stated that "the FBI numbers are almost certainly a significant undercount...many municipalities do not submit hate crime data to the FBI."



But the deeper you dig, the more you see pins of Jeffery Dahmer, shirts with Richard Ramirez, and even tattoos of Charles Manson's face. You see quotes from them, formatted as if they're inspirational. And worst of all, you'll see comments upon comments about how attractive and good-looking these killers are.

Some hotspots for these 'fan accounts' are Tumblr and TikTok. If you search for any serial killer's name on these sites, you'll likely find several posts gushing over these killers. In an article by Adrian Maldonado, titled 'Serial Killers Should Not be Glorified by the Media', he says "Tumblr is a hotbed of serial killers being glorified by users on the site...there is a post by an anonymous user asking, 'Do you think Ted Bundy is hot? I find him very attractive."

No doubt, some people will dispute that it isn't a big deal. It's a harmless 'crush'. Tell that to Nancy Wilcox, Lynette Culver, Carol Kyle, James Doxtator, Jay Sebring, Sharon Tate and her unborn child.

Of course, the only problem here isn't that people find them attractive. It's that there are people in the world who want to be like these killers. They want to be idolized, like what they see on social media. These people can turn into copycats of other deranged killers. Richard Ramirez was inspired by the Hillside Strangler. Seung-Hui Cho, the Virginia Tech shooter, was heavily influenced by the Columbine shooters.

People will argue that nothing dangerous or harmful can come from these 'fan accounts'. But think of all the future victims of copycat serial killers who were misled into thinking they'd be hailed a hero.

There is nothing wrong with being interested in serial killers. It 's normal for us to be intrigued by horror and macabre. But it's not normal when the interest becomes a fascination that swells into obsession and glorification. We need to treat these killers as they are: disgusting and abhorrent people, forgiveness.

#### **COVID-19 Successes and Failures**

As the pandemic continues to spread with no clear end in sight in the United States, many Americans look to other nations and wonder if it had to be this way.

With 27.8 million COVID-19 cases, according to Johns Hopkins University, as of February 17, 2021 and continued case growth, the U.S. COVID-19 response is a clear failure. Compared to nations with much more immediate and far-reaching responses like New Zealand, with only 2,340 cases, or Cuba, with 39,914 cases, the slowed, varied, and weak prevention measures in the US contributed to the world's worst outbreak.

The United States had its first confirmed case of the novel coronavirus on January 21st, 2020. On February 2nd, former Pres. Trump announced a restriction on travel to the United States from China's Hubei province. It wasn't until March 13th when COVID-19 was declared a National Emergency and travel restrictions for non-US Citizens in Europe began, despite the President's proclamation in February that the virus would "miraculously go away" by April. By April 16th, the President was encouraging governors to reopen their states, ignoring the advice of medical experts like Dr. Fauci or Dr. Birx. By May, all 50 states partially or fully reopened, and cases rapidly grew. Throughout the spring, summer, and fall of 2020, the US faced the worst COVID-19 numbers on Earth, surpassing 200,000 deaths in September. A glimmer of hope appeared in December, when the first COVID-19 vaccine was approved for emergency authorization. However, having faced defeat in the presidential election, the White House left the Biden administration with no plans for federal vaccine distribution and production, according to Vice President Harris.

New Zealand, however, acted boldly under the

leadership of Prime Minister Jacinda Ardern. A level 4 lockdown, restricting all non-essential business, was implemented on March 26th. The nation was able to move to a level 3 lockdown after 5 weeks, and ended all stay-at-home orders after just 7 weeks. Unlike the United States, the nation took decisive and unified action to stop the spread. There was little to no resistance to mask mandates, lockdowns, and closings. Individuals acted in the interest of public health rather than taking dangerous and selfish actions. Today, New Zealand stands as an exception among almost every country on Earth, proof that adhering to the words of scientists and the government saves lives. Prime Minister Ardern's leadership was effective because she treated the nation as a "team of 5 million," asking every citizen to unify and respect disease prevention measures.

While Americans bitterly resisted stay-at-home orders, ignored mask mandates, spread disinformation on vaccines and the virus, and reopened gyms, restaurants, and bars, New Zealand and others dramatically reduced the death toll. While the President gave a platform to conspiracy theories, didn't publicly wear a mask until July, and pushed for reopening as cases grew, the Prime Minister pushed unity and science. Today, as over a thousand people die a day in the US, New Zealanders still live in relative safety. The nation is so committed to safety that Auckland, the largest city in the nation, was recently placed under a temporary lockdown over three cases The successes of New Zealand and others serve as an example for the United States of a government willing prioritize public health over all else.

#### Legendary Suns Basketball Players

Since the Phoenix Suns joined the NBA in 1968, they have had a slew of influential and inspiring players on the team. Although they have never won a championship, the Suns have still hosted a variety of highly talented players including Amar'e Stoudemire, Charles Barkley, and the one and only Steve Nash.

Amar'e Stoudemire is an obvious choice as one of the top three most influential basketball players the Suns have ever had. He was the 9th player drafted to the Suns in 2002, he quickly made his presence on the team known. After just one year on the team, he won the NBA Rookie of the Year award. In the following years, his impressive skills on the court led him to play in six NBA All-Star games and was selected as a member of the All-NBA team five times.

Another highly influential player for the Suns is Charles Barkley. He is widely considered one of the most dominant power forwards of all time, shooting 54% overall. For 11 years, Barkley was an NBA

All-Star as well as a regular member of the All-NBA team. His highest honor, however, was being selected as the 1993 NBA Most Valuable Player. Concurrently, Barkley was a member of the 1992 and 1996 US Olympic "Dream Teams," where he won two gold medals.

Although these two are highly impressive, the most influential player the Suns have ever seen is Steve Nash. He played for 18 NBA seasons, and was named an NBA All-Star eight times and additionally was selected for the All-NBA team seven times. He was named the league's Most Valuable Player twice, and in 2006, ESPN named him the 9th best point-guard in history. For a period of time, he led the league in assists and free-throw percentage, causing him to rank as one of the best players in NBA history.

Clearly the Suns' lack of championship wins doesn't define the merit of their team members. Who will be the next legend?

#### **Gaming Industry Carried** 2020 Yushin Son

Let's admit it. 2020 was rough. But, if there was a highlight of the year, it was the rise of gaming. As people were forced indoors, they looked for ways to entertain themselves without going outside.

This is where gaming came in.

2020 started off with a bang with massive, highly anticipated game releases such as Animal Crossing and Call of Duty. Then there were the releases of two new powerhouse consoles: the PS5 and Xbox Series X.

There was no shortage of gamers ready to play either. Four-fifths of all US consumers played a video game in the past six months according to the latest report from the NPD group, which was only a fraction of the good news for the industry.

Greatly surpassing the expected revenues of \$159.3B, the gaming industry accrued a neat \$179.7B and an increased playtime among all demographics, with the most pronounced increase for people aged 35 to 54 years old.

Engagement on all sides of gaming absolutely exploded. People used video games as alternatives for real-life events. An in-game Travis Scott Fortnite concert saw over 12 million concurrent views from players. Schools across the world used sandbox games such as Minecraft and Roblox as graduation sites. Speaking of Minecraft, the explosive prevalence of survival multiplayer (SMP) servers skyrocketed live streaming. Twitch, a popular video game streaming platform, saw 1.49 billion gaming hours watched in April - a 50% increase since March. Steam, another popular PC gaming platform, hit its all-time high concurrent user count of over 20 million people, in March.

The influence gaming has had on the worst year ever is nothing short of astounding, and this will have a rippling impact on years to come.
