

## Corporate Gift Matching

Double your impact! Many employers generously offer to match an employee's donation to benefit local schools. Many companies will also extend the benefits to spouses and retired employees. Since Chandler Unified School District is an instrumentality of the state government as provided by Section 170(c)(1) of the IRS Code we are able to receive matching contributions from employers. Already made a donation? No problem. Most companies will match your gifts for up to 12 months after you've made your donation.

The requirement for the matching portion of a contribution varies by employer. If your gift is eligible for a match, please follow the three simple steps below.

**Step 1:** Locate your employer's name on the list below. (If your employer is not listed, check with your Human Resources Department or company's website to see if they offer gift matching.)

**Step 2:** Obtain a matching gift form from your employer's HR office or check your employer's website for a downloadable form.

**Step 3:** Submit the completed form to your employer.
