1.02 Journey 2025 – World Class Employees

- Outsourcing Substitutes Sandy Cooper explained that the tracking and employment of substitutes had become more challenging with the changes in Prop 206 and leave requirements. The District has been considering partnering with a third party to handle substitutes beginning with the 2019-20 school year. Many districts have already made this choice.
- 2019-20 Administrative Positions

Dr. Casteel explained the changes in administrative positions to-date with the promotion of Amber Stouard as Director of Research and Assessment; Jessica Edgar as Curriculum Director PreK-8; and Leo Schlueter as Director of Elementary Education; leaving principal vacancies at Auxier, Basha and Carlson Elementary Schools.
