2. Miscellaneous Items

2.01 <u>Transportation Updates</u>

What has been done to address challenges we had in the Fall of 2023. Challenge with communication and as to how the new system of requesting busing for students. Tom Dun explained that the old routing software had data that was not exact. It was a challenge at the start of the year. Transportation registration will happen this Spring to ensure better data for the start of the new year. The system is all automated now. There were lots of promises made to ACP but unable to maintain them. Per Policy, busing is provided for elementary students living 1 mile from the school and 1.5 miles for secondary students. It has become a challenge transporting specialized students.
