A.R.S. 15-977 (Classroom Site Fund) requires that a school district governing board must adopt a performance-based compensation system in order to allocate funding from the classroom site fund. The 2024-2025 Proposition 301 Pay for Performance Plan has been approved by the District's SuperProp Committee.

- Anticipated payment of \$700 per staff member to be paid in 2024-2025
- No Professional Development requirements

The CUSD Pay for Performance Plan has two components based on the following:

- 50% (\$350) is contingent upon completion of the Site Learning Experience Plan
- 50% (\$350) is based on Teachers Performance Classification

Approval of this performance-based compensation system will be requested during the February 12, 2025 Regular Board Meeting.

#### 8.03 Fire Alarm Systems at Conley Elementary, Sanborn Elementary and Support Services

The fire alarm systems at Conley Elementary (1994) Sanborn Elementary (1996) and Support Services (1988) are original, and the current systems are obsolete and very difficult to service and maintain.

The District will contract with Copper State Fire Protection on the Mohave contract #22C-CFP2-0606 which complies with all school procurement rules in the amount of \$537.558. Conley Elementary - \$225,370 Sanborn Elementary - \$259,998 Support Services - \$52,190 The scope of the project includes: Remove current FACP, devices and wiring that is not compatible. Install new Notifier Addressable Fire Alarm Panel Install new Annunciator Install full coverage smoke/heat detectors campus wide Includes all engineering and fire alarm permits

Recommend approval of Copper State Fire Protection in the amount of \$537,558 for the fire alarm system replacements at Conley Elementary, Sanborn Elementary and Support Services.
